1.	Ramesh Masih R/o Naarad district Gurdaspur	Regarding kidnapping of his minor daughter (Anita).	Concerned police was directed to appear before the Commission with report. In the report SSP, Gurdaspur stated that concerned persons are being interrogated and if any solid evidence is found against them, strict legal action will be taken. He also mentioned that Anita is being traced and will be found soon.
2.	Poonam Sahotra R/o Prabhat Avenue, Amritsar.	Regarding illegal construction on the property of the complainant.	Concerned police was directed to appear before the Commission with detailed report. In the report SSP, Amritsar (Rural) stated that an agreement has been signed between the concerned parties and the final saled deed of the plot will be registered on 21-5-2021.
3.	William Masih R/o Mohan Nagar, Patti, Tarn Taran	Regarding murder case of his daughter Joti William.	Concerned police was directed to appear before the Commission with report. In the report the Director Bureau of Investigation stated that the FIR has been registered and is under trial in the Hon'ble Court.
4.	Complaint received through social media and newspaper	Regarding the Death/murder of Pastor Sh. Balvinder Masfih, Zira, Ferozepur.	Concerned police was directed to appear before the Commission with report. In the report SSP, FZR has stated that a SIT was constituted and SIR reported that death of Pastor Balvinder Masih was due to an accident.

5.	Miss Merry, Telephone operator, Department of Hospitality, Punjab.	Complaint against R.L. Chopra (Assistant Director, Dept. Of Hospitality) of sexual harassment and Naresh Kumar for demanding bribe.	Case is under investigation.
6.	1. Sonia w/o Swarn Masih. 2. Sanjay Phillip	Case regarding to ownership of St. Andrew Church, Ferozepur.	The Commission investigated the matter and called the concerned persons in the office. After the detailed inquiry it is revealed that the Church under dispute is under the jurisdiction of Ministry Cantonment Board. Therefore, D.C. Ferozepur requested to take the matter with Cantonment Board. SSP FZR has also been requested to maintain peace and harmony.
7.	Wilson Masih r/o Sanjay Gandhi colony, Amritsar	Complaint against Sushant Bhatia, Estate Officer Amritsar regarding demand of bribe and demolition of his shop.	Sh. Sushant Bhatia, Estate Officer M.C. Amritsar and complainant were called in the Commission. Sh. Bhatia agreed to re-construct the Shop of complainant. The matter has been resolved.
8	Prem Kumar Beldar, BBMB, Talwara	Promotion from Beldar to Class III.	The case was enquired into by the Commission on 23-3-2020. From the perusal of record and reply of the Deptt. Irrigation, Punjab and BBMB, Talwara, it was revealed that Prem Kumar Beldar is not eligible for promotion according to his seniority.
