## THE PUNJAB STATE COMMISSION FOR MINORITIES (AMENDMENT) ACT, 2016

(Punjab Act No. 24 of 2016)

AN **ACT** 

further to amend the Punjab State Commission for Minorities Act, 2012.

BE it enacted by the Legislature of the State of Punjab in the Sixtyseventh Year of the Republic of India as follows:-

1. (1) This Act may be called the Punjab State Commission for Short title and Minorities (Amendment) Act, 2016.

- (2) It shall come into force on and with effect from the date of its publication in the Official Gazette.

"(aa)a Vice-Chairperson, a person of eminence and who has done outstanding work regarding safeguarding the interests of the minority communities, to be appointed by the Government;" and
