In this context it is informed that Minority Certificate is not mandatory for getting the benefits of the welfare schemes being implemented by this Ministry. A self certification of the , candidate is accepted by this Ministry. In this regard this Ministry has already issued instructions vide letter No.3/37(2)/2014-SS dated 22-08-2014 (copy enclosed)
